3. Make sure the forms are notarized where indicated and your social security is on the National form for insurance purposes.
4. Enclose a current grade report or ask your school to send it to me. Home schooled students must send an official one also. If I have yours from state finals, you don't need to send another.
5. Enclose a check for \$115.00 which is the total membership fee.
6. Mark all events you might compete in on the state application and have both parents sign next to it.
7. Once again double check that all areas are filled in and signed.

___ Fundraiser. Members are required to sell 25 raffle tickets @ \$1 each and turn in to state secretary by February 1, 2011. These will be handed out at the Fall rodeos or mailed to you after your membership has been processed.
